3. Discharge of the Management Committee's members and the Auditor from all personal responsibility in connection with Private Life Insurance Guarantee Fund activities and management for the year 2022.
4. Appointment of the auditing company for the year 2023.
5. Approval of 2023 budget.



The votes have been calculated in accordance with the provisions of the decision 209/1/19.7.2022 of the Executive Committee of Bank of Greece and based on the registered insurance premiums submitted with the annual contribution statements of the Members for the year 2022. ## PRIVACY NOTICE TO MEMBERS' LEGAL REPRESENTATIVES

The present Notice has the purpose of providing information regarding the collection and processing of personal data by the Private Life Insurance Guarantee Fund ( the "Company") with its registered seat at Sina Str. 2-4, 106 72, Athens, Greece, in its capacity as Data Controller of the personal data of legal and/or authorized representatives of PLIGF members ("Data Subjects" or "You") under the General Data Protection Regulation ("GDPR") and Greek Law 4624/2019 on the protection of personal data.

### 1. Personal Data Categories

We process the personal data you provide us with, including: (1) your identification data (full name, full name of father and mother, ID number) (2) your address, (3) your contact information including your email address, (4) your occupation, and (5) your actions in the context of the representation of any of our Members. This data also includes the information of third parties (proposed candidates & authorized persons).

### 2. Purpose and Lawfulness of Data Processing

The collection and processing of the foregoing data is carried out for the purpose of fulfilling our obligations towards our Members and, more generally, our legal obligations under applicable law, including audits by competent authorities.

### 3. Transfers of Data

We may transfer your personal data to companies that process personal data on our behalf ("data processors"), public authorities in the context of our legal obligations and the Bank of Greece in the context of its supervisory role. We will not transfer your data outside the EEA unless we inform you otherwise.

### 4. Data Retention Period

We will retain your data with for a period of ten (10) years from their collection. However, we may retain your data after the end of the aforementioned period (a) in order to defend our rights and legitimate interests before any competent court and any other public authority until the limitation period for these claims, or (b) if required by applicable law.

### 5. Technical and Organizational Measures

We have taken appropriate technical and organisational security measures to ensure the security of data processing, which are taking place in accordance with the applicable data protection legislation.

### 6. Rights of Data Subjects

You may, at any time, exercise your rights to access, correct or delete, restrict, and object to the processing of your personal data, as well as your right to lodge a complaint before the Personal Data Protection Authority (L. Kifisias 1-3, 11523, Athens, tel. 210- 6475600, [contact@dpa.gr](mailto:contact@dpa.gr)).

For any matter and clarification related to the protection of your personal data you may contact our Data Protection Officer at [dpo@pligf.gr](mailto:dpo@pligf.gr). We normally respond to your request within thirty (30) days of its receipt, with the possibility of extending the deadline by another two (2) months, if necessary, upon serving relevant notice, taking into account the complexity of the request and the number of requests being processed.
