In both cases, the attached "Declaration – Proxy Letter" form must be duly completed, signed by the legal representative and submitted, along with a copy of the representative's ID, no later than Friday, 19 September 2025 at 2:00 p.m. (local time) electronically to kpaxinou@pligf.gr. Each person may represent only one (1) Member of the Fund.

A table indicating the number of votes allocated to each Member - Company is hereby attached. The votes have been calculated in accordance with Decision No. 209/1/19.7.2022 of the Executive Committee of the Bank of Greece, namely on the basis of the gross written premiums reported in the annual contribution statements submitted by the Member - Companies to the Fund for the year 2024. Any objections regarding the calculated number of votes must be submitted in writing, with proper justification, no later than **Friday, 19 September 2025.**

PRIVACY NOTICE TO MEMBERS' LEGAL REPRESENTATIVES

The present Notice has the purpose of providing information regarding the collection and processing of personal data by the Private Life Insurance Guarantee Fund (the "Company") with its registered seat at Sina Str. 2-4, 106 72, Athens, Greece, in its capacity as Data Controller of the personal data of legal and/or authorized representatives of PLIGF members ("Data Subjects" or "You") under the General Data Protection Regulation ("GDPR") and Greek Law 4624/2019 on the protection of personal data.

1. Personal Data Categories

We process the personal data you provide us with, including: (1) your identification data (full name, full name of father and mother, ID number) (2) your address, (3) your contact information including your email address, (4) your occupation, and (5) your actions in the context of the representation of any of our Members. This data also includes the information of third parties (proposed candidates & authorized persons).

2. Purpose and Lawfulness of Data Processing

The collection and processing of the foregoing data is carried out for the purpose of fulfilling our obligations towards our Members and, more generally, our legal obligations under applicable law, including audits by competent authorities.

3. Transfers of Data

5. Technical and Organizational Measures
