The present Notice has the purpose of providing information regarding the collection and processing of personal data by the Private Life Insurance Guarantee Fund (the "Company") with its registered seat at Sina Str. 2-4, 106 72, Athens, Greece, in its capacity as Data Controller of the personal data of legal and/or authorized representatives of PLIGF members ("Data Subjects" or "You") under the General Data Protection Regulation ("GDPR") and Greek Law 4624/2019 on the protection of personal data.

1. Personal Data Categories

We process the personal data you provide us with, including: (1) your identification data (full name, full name of father and mother, ID number) (2) your address, (3) your contact information including your email address, (4) your occupation, and (5) your actions in the context of the representation of any of our Members. This data also includes the information of third parties (proposed candidates & authorized persons).

2. Purpose and Lawfulness of Data Processing
